The mandatory information marked with an asterisk in the agreement is necessary for membership in the DHV and its processing is based on Article 6(1)(b) GDPR. You can choose to provide us with other information but this is not necessary for membership. Processing of these data takes place on the basis of Article 6(1)(a) GDPR.

Data processing takes place with your consent, Article 6(1)(a) GDPR and (1)(b) GDPR, so that we can provide the service associated with membership in the DHV. In particular, this involves individual advice on all matters concerning academic careers and everyday professional life, legal expertise on all matters of university, civil service and salary legislation, copyright, publishing and tax legislation, the monthly journal "Forschung & Lehre" via post or e-paper, regular notification about job openings via email, press statements from the DHV via email, invitations to events of the DHV groups on site via email or post, information and advertising on DHV seminars, DHV coaching offers etc. via email and the monthly email newsletter.

If you have given your consent, you will be mentioned by name as a new member in the supplement to the journal "Forschung & Lehre", which is sent only to DHV members, pursuant to Article 6(1) GDPR. As a DHV representative, you will also receive minutes of meetings of the committees of the DHV by email. Use of your data for this purpose is likewise based on a legitimate interest of the DHV and so on Article 6(1)(f) GDPR.

We shall store your personal data provided in this context for the duration of your membership and, after the end of the agreement, for the period of the tax-law / statutory retention obligations applicable at the time.

Your data shall not be disclosed to third parties unless this is exceptionally necessary for performance of the agreement.

You have the right pursuant to Article 7(3) GDPR to revoke any consent granted at any time. As a result of this we shall no longer be permitted to continue the data processing based on such consent in the future. You also have the right, pursuant to Article 15 GDPR to request information about your personal data processed by us, pursuant to Article 16 GDPR to request immediate rectification of incorrect data or completion your personal data stored by us, pursuant to Article 17 GDPR to request erasure of your personal data stored by us, insofar as processing is not required to exercise the right to freedom of expression and information, to fulfil a legal obligation, for reasons of public interest or to assert, exercise or defend legal claims; pursuant to Article 18 GDPR to request the restriction of processing of your personal data; pursuant to Article 20 GDPR to request the transfer of your data; pursuant to Article 77 GDPR to lodge a complaint with a supervisory authority. If your personal data are processed on the basis of legitimate interests pursuant to Article 6(1)(f) GDPR, you have the right under Article 21 GDPR to object to the processing of your personal data if there are grounds relating to your particular situation.
